Agreement

§ 47 of the Copyright Act gives, inter alia, record companies the right to royalties when sound recordings are played in radio and TV broadcasts, and in other public performances. IFPI Sweden collects and distributes these royalties to the record companies. To receive royalties, it is necessary to submit a claim form after registering on IFPI Sweden's website. Signing on requires a PIN code which is sent to a duly-registered mobile phone number. By registering, you agree to take over responsibility for any claims made against IFPI by other parties who assert that they have a better right to the royalties for the recording in question. Registration authorises IFPI to collect royalties on your behalf under the provisions of § 47, and to enter into such agreements as are necessary for doing so. Whenever the right expires or is transferred to another party, you must deregister. Through this declaration, IFPI takes responsibility for accounting for VAT in accordance with Chapter 6 § 7 of the Value Added Tax Act (1994:200) in relation to royalties for the use of rights. Authorised signatories affirm through their signatures that the specified persons have the authority to register and deregister the company's rights with IFPI Sweden.
